<u>DUTIES</u>: Under the close supervision of a Program Specialist 3, Program Specialist 4, or other supervisory officer in a State department or agency, as a trainee and productive worker, receives on-the-job training while assisting in the professional, administrative, and analytical work to promote the planning, operation, implementation, monitoring and/or evaluation of human or social service programs, programs serving the socio-economic needs of specific clients populations, or regulatory programs designed to ensure public safety, health and welfare, or protection of the environment; completes assignments which provide practical Program Specialist experience; does other related work. REQUIREMENTS

<u>NOTE</u>: Applicants must meet one of the following or a combination of both experience and education. Thirty (30) semester hour credits are equal to one (1) year of relevant experience.

Four (4) years of professional experience relevant to the position.

<u>OR</u>

Possession of a bachelor's degree from an accredited college or university.

<u>NOTE</u>: "Professional experience" refers to work that is analytical, evaluative, and interpretive; requires a range of basic knowledge of the profession's concepts and practices; and is performed with the authority to act and make accurate and informed decisions.

LICENSE: Appointee will be required to possess a driver's license valid in New Jersey.

<u>ADVANCEMENT</u>: Appointees who successfully complete the 12-month training program will be eligible for advancement to the title Program Specialist 1. *The inability of an employee in a trainee title to attain a level of performance warranting advancement to the title indicated shall be considered cause for separation.*

<u>PREFERENCE</u>: Preference will be given to applicants who are comfortable with in and out-of-state travel and with public speaking to small and large groups.

<u>SAME APPLICANTS</u>: If you are applying under the NJ CSC "SAME" program, your Schedule A or B letter must be submitted along with your resume and any other required supporting documents indicated on the announcement by the closing date indicated below.
