An opportunity currently exists in the unclassified service with the Department of Law and Public Safety, Office of the Insurance Fraud Prosecutor, for applicants who meet the requirements specified below:

## **NUMBER OF POSITIONS AVAILABLE:** One (1)

<u>DUTIES</u>: Under general supervision of a Bureau Chief and Assistant Bureau Chief in the Office of the Insurance Fraud Prosecutor, CLASS Unit, conducts complex and thorough investigations relating to violations of New Jersey laws, including, but not limited to, all types of private insurance fraud. This position will work closely with detectives and prosecutors in furtherance of criminal investigations, performing the following duties: case referral/tip development; securing, reviewing, and analyzing financial records/statements, official reports, applications, claims data/files, medical records/reports, audio/video recordings, and other material; utilizing various databases for additional information gathering; corresponding with appropriate State agencies, insurance companies, or other entities; memorializing findings in a clear and accurate form, including reports, charts, or graphs; and assisting on special projects. In addition, this position will perform other related duties as required. This position may also require non-traditional work hours, including evenings on short deadlines for certain assignments, with or without advance notice, and may require travel to perform the aforementioned responsibilities.

## **REQUIREMENTS**

**NOTE:** Applicants must meet one of the following or a combination of both experience and education. Thirty (30) semester hour credits are equal to one (1) year of relevant experience.

Seven (7) years of professional experience in the conduct of civil or criminal investigations related to compliance, enforcement, detection, and surveillance activity, including the preparation of investigative reports. **OR** Seven (7) years of professional experience in the conduct of investigative administrative audits and/or regulatory examinations of records maintained by businesses and organizations. **OR** Seven (7) years of professional experience in the conduct of investigations for the government, the military, consumer protection programs, public advocacy organizations, or the public interest.

<u>OR</u>

Possession of a bachelor's degree from an accredited college or university; and three (3) years of the above-mentioned professional experience.

<u>OR</u>

Possession of a juris doctorate or a master's degree in Criminal Justice, Public Administration, Business Administration, Law, or a related field; and two (2) years of the above-mentioned professional experience.

<u>NOTE</u>: Completion of a supervised internship field placement of 300 hours in an undergraduate curriculum in Criminal Justice or a related degree program may be substituted for one (1) year of the non-supervisory experience.

**NOTE:** "Professional experience" refers to work that is creative, analytical, evaluative, and interpretive; requires a range and depth of specialized knowledge of the profession's principles, concepts, theories, and practices; and is performed with the authority to act according to one's own judgment and make accurate and informed decisions.

**LICENSE:** Appointee will be required to possess a driver's license valid in New Jersey.

<u>SAME APPLICANTS</u>: If you are applying under the NJ "SAME" program, your Schedule A or B letter must be submitted along with your resume and any other required supporting documents indicated on the announcement by the closing date indicated below. **RESUME NOTE:** Eligibility determinations for experience and education will be based upon the resume and unofficial transcripts submitted at the time of application. Applicants who possess foreign degrees (degrees earned outside of the U.S.) are required to provide a CSC approved evaluation indicating the U.S. equivalency, with a course-by-course breakdown, prior to the closing date (see <u>CSC foreign degree information</u>). Failure to do so may result in disqualification of your education towards eligibility.

All offers of employment are conditional subject to the applicant agreeing to and then passing a background check that may include fingerprinting.
