**REQUIREMENTS**

**EDUCATION:** Possession of a valid New Jersey Teacher's Certification (Standard, Certificate of Eligibility with Advanced Standing, or Certificate of Eligibility) issued by the Board of Examiners of the New Jersey Department of Education, authorizing instruction at least one of the following subject areas: **English, Math, any Science, Social Studies, Health/PE, Business, World Language, Art, ESL, Driver's Ed, FCS, Music, Theater, Special Education, CTE, Elementary Education.**

**EXPERIENCE:** Thirty-six (36) months of full-time, properly certified teaching experience in an approved school, earned after the receipt of the New Jersey Standard Teacher's Certificate.

**LICENSE:** Appointee will be required to possess a driver's license valid in New Jersey.

**RESUME NOTE:** Eligibility determinations will only be based upon information presented in the resume.
